**City of Petaluma Re-roof Cool Roofs**  
**CEC reg. 149 (b) 1 B**

City of Petaluma Cool Roofs over the counter permit handout for low slope (2:12 slope or less) Nonresidential re-roofs (where more than 50% of the roof is re-roofed or more than 2000 sf, whichever is less). Applies to all non-residential re-roofs over conditioned space except "I" occupancies (jails, hospitals, etc). Note that Hotels and Motels are also exempt.

Re-roof Cool Roof products may come in the form of modified bitumen, built up roofing, single ply thermo plastic, fluid applied roofing, coatings, or something else. All products shall have at least 0.70 initial reflectance and 0.75 initial emittance and a CRRC Product ID number. All re-roof products must be labeled as indicated below:

The contractor should specify on the application and then permit staff should check the product by going to the CRRC rated products directory at <http://www.coolroofs.org/ratedproductsdirectory.html>. Here is an example showing approved roofing type products from the directory:
